## Faculty Spotlight



### **Dr. X'unei Lance Twitchell**

Dr. X'unei Lance Twitchell, UAS Professor of Alaska Native Languages, won an **Emmy award** for Outstanding Writing for a Preschool Animated Series on March 16, 2025. Twitchell writes scripts for Molly of Denali, a PBS Kids show that airs nationwide every weekday.

The winning episode, "Not a Mascot," focused on the main character helping an Alaskan basketball team change their stereotypical Indigenous mascot to a new, non-discriminatory mascot. The plot of the show parallels Twitchell's daily work to fight stereotypes and bigotry against Indigenous peoples and ways of being in Alaska and the UA system. His focus at UAS and in Southeast Alaska is the preservation and revitalization of Alaska Native languages and cultures. He deserves all the recognition he's gotten for his Emmy Award!

## UAF's New Organizational Vice President: Ingrid Johnson



Congratulations to Dr. Ingrid Johnson, who won the recent special election to replace our previous UAF Org VP, who is now dean of UAF's School of Education. Ingrid's role will continue through the rest of the VP term, which ends on June 30, 2027.

Thanks also to Art Nash, who also ran for the position and will continue serving in his role on the UNAC Representative Assembly. Our next regularly scheduled elections will take place next winter (early 2026) for president, secretary, and treasurer.

### UNAC's Petition to the UA BOR Regarding Their Anti-DEI Motion

356 UNAC members signed our [petition](#) in under one week. Thank you to everyone who signed it! This is the type of solidarity we need to show right now. We delivered the petition to members of the BOR on Monday, March 10, 2025, and have heard no response. We encourage you to engage with media in interviews when asked to do so, and to continue pressuring the regents to reconsider this motion. In the end, it will not protect UA from whatever is coming next out of D.C.



### Anti-DEI Policy Compliance

If a UA employee other than your direct supervisor tells you to change language or content on any of your print or virtual materials, including course offerings and websites, you are not required to comply.

You cannot be accused of insubordination, which is a fireable offense, unless the order comes directly from your supervisor. If your supervisor orders you to make changes, immediately contact your union at [contract@unac4996ak.com](mailto:contract@unac4996ak.com) for advice before responding or complying.

President Pitney said in her March 17, 2025, [email](#) regarding compliance with the BOR's DEI policy that they were not touching academic programs. With that in mind, you should not hesitate to get in touch with your union if your academic program is being pressured to make any type of changes.

### Federal Funding Threats

## Know Your Union Rights to Representation

If your supervisor calls you into a meeting, request an agenda for the meeting. If no agenda is provided, we recommend you tell them you will bring a union representative with you to the meeting. Then contact your Org VP and our union office at [contract.unac4996ak.com](http://contract.unac4996ak.com). Your supervisor is legally required to schedule the meeting at a time when your union representative is available. *This is called your Weingarten Rights.* Watch the video below for more details.



If you have a work situation that you're not sure how to deal with, your UNAC Org VP is a good first person to talk with. They're bound by confidentiality and will help you to the best of their abilities. The video below gives a few examples of when to contact your union.

## Workloads

While your dean or director ultimately sets your workload, they are required to use the workload you submitted to them as a starting point and should meet with you to discuss any changes before making them. Past precedent matters, meaning the number of workload units you have historically gotten for an activity on your workload should not change unless your role in that activity changes (ex: chairing a committee vs. being a committee member).

It is in your best interest to be familiar with Article 13: Workloads, in our [CBA](#) so you know your rights. We also encourage you to share and compare your workload with your colleagues; transparency helps create equity. We do vastly different types of work across the system, but the amount of work we do should be equitable (oops is that a banned word?)

## Faculty Regent Bill Update

The Alaska Legislature is considering bills to add a faculty member to the UA Board of Regents. The House Bill (**HB10**), will be scheduled in the House Finance Committee for amendments and a vote on whether to pass the bill to the full House for a final, floor vote. The Senate Bill (**SB118**) had its first hearing in the Senate Education Committee on March 26, 2025, at 3:30 pm. To become law, both bills have to pass through their respective committees and then pass a floor vote by each body before passing a vote of the full legislature and being signed (not vetoed) by the governor.

HB10 is sponsored by Representative Ashley Carrick (Fairbanks), Representative Zach Fields (Anchorage) and Representative Ky Holland (Anchorage)

SB118 is sponsored by the Senate State Affairs Committee. The committee decided to sponsor this bill following a **presentation to the committee** by UAS's Faculty Senate President, Brian Blitz, and former President/Faculty Alliance Chair, Jennifer Ward.

## **Check Your Biweekly Paystubs**

Sometimes the UA payroll department makes a mistake. It's up to you to catch those mistakes. The biweekly email from [ua-webpay@alaska.edu](mailto:ua-webpay@alaska.edu) announcing that your pay information is available is a good reminder to *check your paystub for accuracy*. Make sure your union dues are being deducted if you're a dues payer ([join here](#) if you're not); make sure your leave accrual is correct; make sure you're in the correct healthcare plan. If you don't notice mistakes in a timely manner, it is much more difficult or impossible to correct them. ## **Use Your Faculty Time Off or Cash-In up to Five Days**

**To use your Faculty Time Off (FTO)**, claim it on your timesheet for the appropriate dates.

**To cash in up to 5 days of your FTO** in lieu of taking time off, fill out the [FTO Cash-In form](#).

## **Strike Solidarity Corner**

- 1,800+ faculty at the University of Oregon voted to authorize a strike, with 89% of their members voting and 92% voting yes. Their union is one of several other United Academics chapters throughout the US; we can learn a lot from them! They've set March 31, 2025, as their strike date. ([more here](#))
- 4,000 student workers at the University of Oregon also voted to authorize a strike, with 60% of the unit voting, with 94.5% of voters authorizing a strike. They are negotiating their first contract with UO. ([more here](#))
- 1,200 faculty and staff at the Philadelphia Community College voted to authorize a strike, with 90% of the unit voting; 97% voted to authorize a strike. ([more here](#))

- A 24-hour, nationwide strike in Panama was called by construction and teachers unions in response to unfavorable changes to the country's social security law. ([more here](#))


# UNAC Goes to the Theatre!

Join your UAF faculty colleagues for an evening of union-themed comradery and support UAF arts!


5 PM - 7 PM: Meet at the Pub for pizza and beer.
