UNAC thus compromised by agreeing to only allow our bargaining unit members to observe. Even this compromise has led UA's team to remark that it's hard to have discussions with an audience. Rest assured, UNAC fully supports our bargaining unit members' rights to observe our negotiations, which both teams agreed to in our ground rules.

Management's team has reported that they are working on a comprehensive package and have indicated that it will be ready for our next session on Monday, October 14.
